TERMS AND CONDITIONS

Background

BRUNSWICK HEADS CHAMBER OF COMMERCE is holding the 4th **BRUNSWICK HEADS SIMPLE PLEASURES PHOTOGRAPHY COMPETITION**. The theme is **BRUNSWICK HEADS Simple Pleasures** and it is hoped that each entrant will find inspiration within the village and surrounds of BRUNSWICK HEADS. The aim is to collect a diverse range of material that will depict a broad and appealing picture of BRUNSWICK HEADS.

Permission is sought from all entrants to select some of the entries for use in marketing BRUNSWICK HEADS. Selected photographs will **only** be used in the marketing of BRUNSWICK HEADS. Proceeds will go towards the production of the marketing materials and for use in producing community events.

Selected entries will be exhibited within the CBD area of BRUNSWICK HEADS in shop windows and local businesses. Entrants will be required to pay an entry fee (see below).

Prizes will be awarded to each category with a People's Choice Award selected from all entries.

1. Brunswick Heads Simple Pleasures "Village People"

The first three Photography competitions had the theme Brunswick Heads Simple Pleasures. Participants found inspiration within the village and surrounds of Brunswick Heads.

In 2008, the fourth Photography Competition, the organizing committee has agreed that the Simple Pleasures of Brunswick Heads will continue to be the main theme. It was decided to include an additional inspiration to this theme as follows, **Brunswick Heads Simple Pleasures "Village People"**

Village people can encompass the human characters of Brunswick Heads as well as other characters such as birds, dogs and perhaps your well loved favourite boat.

2. EXHIBITION DATES

The exhibition will be on display from Saturday August 23rd to Sunday September 14th 2008. Winners will be announced on Sunday September 14th 2008 venue to be confirmed at later date. The public will be able to vote for the People's Choice Award up to 12 p.m. on Sunday September 14th 2008. Voting forms will be available at various exhibition spots with placement bins nearby.

3. CATEGORIES, PRIZES and ENTRY FEES

Total prizes - value around \$1,000 (to be confirmed).

Category One

12 years & under \$5 entry fee

Category Two

13-18 years old \$10 entry fee

Category Three

19 years old & over \$15 entry fee

Acquisition Prize (overall winner)

All categories no additional fee

Acquisition Prize means that the winning photograph will be acquired by the sponsor in return for the prize (TBA), and displayed at the discretion of the sponsor.

People's Choice Award

All categories no additional fee

4. ENTRY and EXHIBITION CONDITIONS

Closing date for entries is **Friday August 8th 2008**. A maximum of 3 entries per person on separate entry forms.

Entries should be submitted with a brief CV of the photographer, and a brief description of the submitted photograph.

- Photographs must be A4 size format
- Photographs may be black and white or colour and should be properly processed and on photographic paper
- Photographs must be **unmounted**.
- Copy of Photographs must be placed on CD on a high resolution jpeg file, or jpeg file emailed to John Humphries at events@brunswickheads.org.au
- Installation and exhibition is at the discretion of the organisers.

If entrants require their material returned, a stamped addressed envelope must be included with each entry. Entries should be sent to **PHOTOGRAPHY COMPETITION C/o Brunswick Heads Chamber of Commerce, PO Box 184 , Brunswick Heads NSW 2483** by Friday August 8th 2008. **Entries should be postmarked no later than August 8th 2008. Entries can also be delivered during business hours to Second-hand Rose, 8 Park St, Brunswick Heads and the Tourist Information Centre, Park St Brunswick Heads.**

4. SELECTION and JUDGING

The organisers will endeavour to display all entries. In the event that an unprecedented number of entries are received, a selection panel will be formed to view entries and preselect photographs for display in the exhibition. Unsuccessful entries will be returned. The Selection Panel's decision is final and no correspondence will be entered into.

The judge's decision is final and no correspondence will be entered into.
Prizes will be announced on Sunday September 14th 2008.

5. SALE OF PHOTOGRAPHS

All successful entries are eligible to be submitted for sale during the exhibition. Entrants are requested to determine the sale price of their entry. 70% of each sale will go to the photographer, 20% to the Brunswick Heads Chamber of Commerce to cover installation and administrative costs of the **PHOTOGRAPHY COMPETITION**, and 10% to the displaying business.

6. RISK MANAGEMENT

All due care will be taken to assure the safety of entries but photographers exhibit at their own risk.

7. COPYRIGHT

Copyright remains with the photographer. **However, the entrant (Photographer) authorises and licences the Brunswick Heads Chamber of Commerce as set out in the application form attached.**
